**SECTION VII - HEALTH AND FIRST AID**

**PRIMARY ROUTES OF ENTRY & EFFECTS OF OVER EXPOSURE:**  
**Eyes:** Causes severe irritation, redness, tearing and blurred vision. May aggravate existing eye conditions.  
**Skin:** Prolonged contact causes irritation, redness and possible burns. May aggravate existing skin conditions.  
**Inhalation:** Inhalation of mist can cause irritation of nasal and respiratory passages and damage to mucous membranes. May aggravate existing respiratory conditions. Prolonged or repeated inhalation may cause headaches, dizziness, drowsiness, and unconsciousness. Abusive overexposure may cause mild, reversible kidney and liver effects, blood abnormalities and other central nervous system effects, including death.  
**Ingestion:** Can cause severe irritation and damage to mucous membranes and deep tissue. Aspiration of the material into the lungs could cause severe pulmonary injury, possibly progressing to death.
